Topic: Roth Conversions:

Who, What, Where and When

Roth conversions are a hot topic right now, as the income limitations that prevented many taxpayers from employing this strategy in past years were repealed as of January 1st. Are Roth conversions the greatest thing since sliced bread, as the enthusiasm of the consumer press seems to indicate? In this presentation, you'll become familiar with the mechanics of Roth conversions and recharacterizations, and learn how to identify which taxpayers are and are not likely candidates for this useful -- but not universally appropriate -- tax strategy.
